GORCHES Y PEÑALOSARECOGNITION OF PUBLISHED REGISTRATIONS OF IRANIAN APPELLATIONS OF ORIGIN [Read more...](#)

On April 24, 2024, four foreign protected Appellations of Origin were published in Official Gazette. These include "Handmade Carpets of Josheghan", "Kalamkari of Isfahan", "Handmade Carpets of Bijar" and "Iranian Hamadan Garlic".

Mentioned registrations -all Iranian nationality and with the same domicile, although with different geographical areas of production, extraction and processing- reflect Iran's cultural diversity and excellence in craftsmanship and agriculture. These publications, in accordance with Article 324 of the Federal Law for the Protection of Industrial Property, provide information on the Appellations of Origin, and give their holders the ability to take legal action to safeguard their rights over these unique and distinctive products as established in Article 325 of the same law.

RULING OF THE SUPREME COURT OF JUSTICE OF THE NATION ON LEGAL INTEREST IN ADMINISTRATIVE PROCEEDINGS: STRENGTHENING LEGAL CERTAINTY IN INDUSTRIAL PROPERTY [Read more...](#)

On April 19, 2024, the Second Chamber of the Supreme Court of Justice of the Nation issued the thesis with digital registry 2028633, focused on article 188 of the Industrial Property Law, already abrogated. The thesis addressed the legitimacy of the requirement of legal interest to initiate administrative proceedings at the request of a party, highlighting its alignment with the right to effective judicial protection.

By determining that this requirement does not violate the rights of the applicants, but rather safeguards their legal spheres, the decision strengthens legal certainty in the field of industrial property. This ruling establishes an important precedent by clarifying the conditions for taking legal action in matters related to inventions and protected rights, which contributes to generate a more transparent and reliable legal environment for all the actors involved.
